

## **PUBLIC NOTICE OF THE REVISION OF THE LIST OF ELECTORS**

**MRC du Golfe-du-Saint-Laurent**  
**Polling day: November 02, 2025**

By this public notice, Karine Monger, returning officer, announces the following to the electors of the Regional County Municipality (RCM).

1. The list of electors was filed at the office of the RCM on October 03, 2025.

It is currently under review.

2. To vote for the warden, you must be entered on the list of electors.

3. You have the right to be entered on the list of electors, if, on polling day :

- You are 18 years of age or older;
- You are a Canadian citizen;
- You have not lost your right to vote due to tutorship;
- You have not been convicted of a corrupt electoral practice in the previous five years.

– In addition, you must meet **one** of the following two conditions on November 02, 2025 :

- Be domiciled on the territory of the RCM and for at least six months in Quebec;
- For at least 45 days, own an immovable or occupy a business establishment located on the territory of the RCM.

**NOTE :** If you are not domiciled in the RCM and want to exercise your right to vote, you will need to send an application for entry or power of attorney to the returning officer.

If you are an elector domiciled in a local municipality on the territory of the RCM, you will be able to consult the list of electors and submit an application for entry, striking or correction before the board of revisors of that municipality. You must consult the municipality's public notice of review to find out the terms and conditions of the review.
